

Decree of the Director General n. 104 of 24 April 2024

List of complete proposals received and change to the composition of the Evaluation committee of the third phase of the Innovation Partnership entitled "Building green and climate neutral city hubs across European cities" – contract notice 2023/S 201-632428 - published under the framework of the CLIMABOROUGH project.

- However, two more partners of the Climaborough consortium asked to be involved in the
 third phase of the evaluation procedure, namely: Metodiyka Tarlyovska (City of Sofia) and
 Laura Ribotta (City of Turin). Each of them has provided a CV and a declaration of absence
 of conflict of interest, including an acknowledgement that no remuneration is expected
 for the planned assignments. Both documents are kept in a secure file to be documented
 and produced in case of request;
