

Decree of the Director General n. 171 of 5 July 2024

Definitive award of 12 of the 15 received applications to the Innovation Partnership entitled “Building green and climate neutral city hubs across European cities” – contract notice 2023/S 201-632428 - published under the framework of the CLIMABOROUGH project.
