



**Decree of the Director General N. 98/25/I of 8 May 2025**

**Postponement of the deadline to candidate to the first phase of the Innovation Partnership entitled “Building green and climate neutral city hubs across European cities (II<sup>nd</sup> Edition Follower cities)” – contract notice 193321-2025 – published on TED on 26 March 2025 under the framework of the CLIMABOROUGH project.**

Whereas:

- The first phase of the Innovation Partnership is due to expire on 9 May 2025 at 23:59 Brussels time, as per the Contract Notice;
