

Award of the candidatures to second phase of the Innovation Partnership entitled “Building green and climate neutral city hubs across European cities (II edition - follower cities)” – contract notice 300530-2025 changing the previous version 193321-2025 – published under the framework of the CLIMABOROUGH project on the OJ S 90/2025 of 12/05/2025 and earlier on the OJ S 60/2025 of 26/03/2025.

I, the undersigned Simone Gheri, Director General of Anci Toscana

- in my position of Single Responsible Person (RUP in Italian language) for the aforementioned public procurement procedure, as stipulated in the Tender documentation published on 26 March 2025 on TED – the online Supplement of the Official Journal of the European Union – as well as on the official website of the CLIMABOROUGH project in a dedicated section available at: <https://climaborough.eu/public-procurement/follower-cities-climaborough-tender/>

Whereas:

- On 30 May 2025 at 23:59 the first phase of the Innovation Partnership expired;
- By the above deadline, 37 economic operators, single or associate, validly submitted their candidatures to be invited to submit a bid for one or more of the 5 tendered lots, as requested by the Tender Regulations (Annex 1 to the Contract Notice), using the GoodGrants™ electronic submission platform described in Annex 2 to the Contract Notice;
- An evaluation committee was appointed with my Decree No. 129/25/I dated 10 June 2025;
- The evaluation committee immediately started to evaluate the received candidatures, each accompanied by a number of attachments, with the aim of shortlisting those (maximum 6 per lot) demonstrating to hold all the requisites for being invited to the next phase of the tender procedure, or in case the number of eligible candidates exceeded the maximum threshold of 6 per lot, ranking them according to the criteria stated in Annex 1 to the Contract Notice, to identify and select the best 6 of each lot;
- After opening the individual application folders on the GoodGrants™ platform, it was clarified that the 37 economic operators corresponded to 59 distinct applicants, while the number of applications shown in the “submitted” or “resubmitted” status was 55. The difference was due to a mistake done by “383-Hub #2 Waste and Circularity Sofia” and “387-BeSaFe Pilsen” who incorrectly submitted a single electronic package with all the information concerning the group of applicants, instead of distinct applications for each member of the group (namely VUB & CDXI Solutions PC for #383 and Cig IT, Magna BSP & Adesso Basta ODV for #387). Additionally the application entitled “393-BET-ON-WASTE-IN-PRIJEDOR” should have included as separate folder the information concerning one subcontractor, Re Learn srl. Considering those mistakes of minor importance, the evaluation committee decided to include all the members of #383, #387 and #393 among the received applications, which brought their final number from 55 to 59;
- Further to the above, it became evident after considering the received applications one by one, that the two groups candidating to Lot 1 using the distinct acronyms “384-Emmaüs Connect”, “397-Synergie IT” and “398-Synergie IT” were actually part of the same economic operator, who was renamed “Emmaüs Connect+Synergie IT” for the purposes of evaluation. Likewise, the two groups candidating to Lot 5 using the distinct acronyms “433-CSCC Pilsen” and “423-EyeMonitor” were found to be actually part of the same economic operator, who was renamed “CSCC Pilsen+EyeMonitor”. As a result, the final number of distinct economic operators (single

or associate) candidating to the 5 lots of the tender was reduced to 35 instead of the initial 37;

- On 19 June 2025, 41 applicants were invited to submit clarifications on the previously supplied documentation, using the GoodGrants™ electronic platform, which was temporarily reopened to that purpose, by the newly assigned deadline of 25 June 2025 at 23:59. The list of those applicants is presented as Annex 1 to this decree;
- The remaining 18 applicants, listed in Annex 2, were not asked to provide any integration, for the following reasons: 14 of them had in fact uploaded all the information required by the Tender Regulations, while the other 4, despite having submitted their application in time, had the respective application packages missing of all fundamental attachments, as described in Annex 2. These are: 411 - Pêche Strategy (Issy-les-Moulineaux), 416 - Building green and climate-neutral city hubs across European cities - Grenoble (FR) - PIRENE SRL, 417 - Climate Budget and Zero Carbon Challenge for Issy-les-Moulineaux, France - PIRENE SRL, and 418 - Sustainable School Mobility in Pilsen, Czech Republic - PIRENE SRL;
- The following 2 applicants were mistakenly asked to provide integrations, as their applications were found on the GoodGrants™ platform to be still in the “In progress” status, therefore not admissible to the competition: “409-Kunak Technologies” and “435- Pěšky městem”, both from Pilsen;
- Of the 41 applicants for which the GoodGrants™ platform was reopened, only 31 submitted the requested clarifications on time. On 1 July 2025, 8 of them were contacted by phone and email to provide the requested information until 4 July 2025, which they did. For the remaining 2, it was decided that the missing information was not substantial, and therefore the evaluation could be continued also for the 2 of them. All relevant details are provided in Annex 2;
- The following applicant did not supply the requested information to calculate the solvency ratio: “433-CSCC Pilsen”. Therefore, it was decided to exclude it from the evaluation, meaning that the renamed economic operator “CSCC Pilsen+EyeMonitor” was left in the competition as “423-EyeMonitor” only;
- On 26 June 2025, the group of economic operators collectively named “Pěšky městem (Pilsen)” composed of 3 co-applicants (#395, #413 and #420), sent an email of withdrawal from the competition, thus reducing the number of economic operators from 35 to 34;
- On 17 July 2025, the evaluation committee could finalise the evaluation results using the entirety of received documentations and clarifications;
- The following applicant did not meet the minimum requirement of 5% for the solvency ratio: “428-Follower Cities CLIMABOROUGH Tender”. Therefore, it was decided to exclude it from the competition;
- The following Annexes were produced by the evaluation committee: 1) list of the requests for clarification to participants in the Call for tenders; 2) list of the applicants who were not asked to provide integrations; 3) list of the applicants who withdrew from the competition during the evaluation phase; 4) list of the applicants who were excluded from the competition; 5) individual evaluation sheets of all the received candidatures (available only on request);
- Based on the evaluation results as presented in Annex 5) and considering the recommendation from the evaluation committee to retain all candidates (including above the threshold of 6 per lot) showing a positive score at the end of the evaluation process;
