



Decree of the Director General N. 190/25/I dated 08 September 2025

Appointment of the members of the Evaluation committee of the second phase of the Innovation Partnership entitled “Building green and climate neutral city hubs across European cities (II edition - follower cities)” – contract notice 300530-2025 changing the previous version 193321-2025 – published under the framework of the CLIMABOROUGH project on the OJ S 90/2025 of 12/05/2025 and earlier on the OJ S 60/2025 of 26/03/2025.

I the undersigned Simone Gheri, Director General of Anci Toscana

- in my position of Single Responsible Person (RUP in Italian language) for the aforementioned public procurement procedure, as stipulated in the Tender documentation published on 26 March 2025 on TED – the online Supplement of the Official Journal of the European Union – as well as on the official website of the CLIMABOROUGH project in a dedicated section available at the following URL: <https://climaborough.eu/public-procurement/follower-cities-climaborough-tender/>

Whereas:

- On 29 August 2025 at 23:59 Brussels time the second phase of the Innovation Partnership has expired;
- Within this deadline, 23 of the 27 economic operators, single or associated, who were invited to submit their technical offers for the 5 tendered lots by my previous Decree No. 170/25/I of 22 July 2025, actually presented their applications;
- It is now required to proceed with the negotiation of received applications, in accordance with § 4.5 of Annex 1 to the Contract notice (“Tender Regulations”), not before having assessed the fulfilment of the minimum requirements listed for each lot in Attachment 2 (“Specific Requirements”) to the Tender Regulations;
- According to Annex 1, the indicative deadline for the conclusion of the negotiations is approximately one month after the deadline for Phase 2 submissions. Therefore, it can be set at 30 September 2025;
- It is necessary to appoint the members of the Evaluation Committee for this second phase of the Innovation Partnership procedure, with a time-limited mandate as specified above;
- The Tender Regulations do not contain any prescription on the number and profiles of the members of the Evaluation Committee;
- However, it is necessary to assess the level of knowledge and expertise of the candidate members as well as the absence of conflicts of interest before their appointment;
- The following list of 11 candidate members was formulated in agreement with the CLIMABOROUGH project partners:

- Each of the above-mentioned 11 candidates accepted the invitation, providing a CV and a declaration of absence of conflicts of interest, including an acknowledgement that no remuneration is foreseen for the tasks involved. Both documents are kept in a secure archive for documentation and to be shown in case of request;
- Moreover, in accordance with Decree of the Director General Prot. n. 125/25/I of 6 June 2025, also the three members of the Advisory Board established therein – **Mor Harir, Tomas Matraia, and Valerio Barberis** – shall join the Evaluation Committee, since the evaluation of received proposals in the framework of the 2nd call for tender concerning the five follower cities was officially included among their technical tasks;
- From the above-mentioned Advisory Board members, a declaration of absence of conflicts of interest was also withdrawn, and is kept in a secure archive;

Take the following decisions:

- 1) To establish the Evaluation Committee for Phase 2 of the aforementioned procedure, composed of 15 members, the undersigned as Single Responsible Person (RUP) and the 14 candidates listed above:
