



Decree of the Director General N. 212/25/I dated 29 September 2025

List of the invited applicants to the third phase of the Innovation Partnership entitled ‘Building green and climate neutral city hubs across European cities’ – contract notice 300530-2025 changing the previous version 193321-2025 – published under the framework of the CLIMABOROUGH project on the OJ S 90/2025 of 12/05/2025 and earlier on the OJ S 60/2025 of 26/03/2025.

I the undersigned Simone Gheri, Director General of Anci Toscana

- in my position of Single Responsible Person (RUP in Italian language) for the aforementioned public procurement procedure, as stipulated in the Tender documentation published on 26 March 2025 on TED – the online Supplement of the Official Journal of the European Union – as well as on the official website of the CLIMABOROUGH project in a dedicated section available at the following URL: <https://climaborough.eu/public-procurement/follower-cities-climaborough-tender/>

Whereas:

- By previous Decree No. 190/25/I of 8 September 2025, I established the Evaluation Committee for Phase 2 of the aforementioned procedure, composed of 15 members, including the undersigned as Single Responsible Person (RUP);
- The Evaluation Committee held its inaugural meeting on 12 September 2025 at 11:30 CEST in a public session, followed by a private meeting to start the evaluation procedure;
- Each of the 23 applications received on the GoodGrants™ platform by the deadline of Phase 2 (August 29th, 2025 at 23:59 CET) was preliminarily examined by the members of the Evaluation Committee, in order to verify whether the minimum requirements set out in Annex 2 of the Tender regulations were met or only partially met;
- Between September 15th and 26th, 2025, 23 bilateral negotiation meetings were held with the applicants to the 2nd phase of this competition. All the meetings were recorded, and participants were informed of the recording and gave their prior consent. The recordings were stored in a secure server of ANCI Toscana, and will never be shared with anyone, except by Court order;
