



Decree of the Director General n. 259/25/I of 11 November 2025

Start of the evaluation of the third phase of the Innovation Partnership entitled “Building green and climate neutral city hubs across European cities” – contract notice 300530-2025 changing the previous version 193321-2025 – published under the framework of the CLIMABOROUGH project on the OJ S 90/2025 of 12/05/2025 and earlier on the OJ S 60/2025 of 26/03/2025.

- In my position of Single Responsible Person (RUP in Italian language) for the aforementioned public procurement procedure, as stipulated in the Tender documentation published on 26 March 2025 on TED – the online Supplement of the Official Journal of the European Union – as well as on the official website of the CLIMABOROUGH project in a dedicated section available at the following URL: <https://climaborough.eu/public-procurement/follower-citiesclimaborough-tender/>

Whereas

- With my previous Decree No. 212/25/I of 29 September 2025, I approved the list of the 22 economic operators to be invited to the third phase of this competition, as they met the minimum requirements specified in the Call for Tender (List B of the Decree);
- During the week between 15 and 19 September, a bilateral negotiation meeting had been held with each of them, with the purpose of improving the quality of their Technical Offer above the minimum requirements of the Call;
- Each economic operator featured on that List B was sent an email inviting to resubmit the same or a modified Technical Offer, accompanied by a Financial Offer, no later than Friday, October 31st, 2025 at 23:59 CET using the GoodGrantsTM platform;
