



Minutes of the internal meeting of 10 December 2025

Related to the supplementary competition for the award of a second winner in the Sofia lot of the third phase of the Innovation Partnership entitled “Building green and climate neutral city hubs across European cities” – contract notice 300530-2025 changing the previous version 193321-2025 – published under the framework of the CLIMABOROUGH project on the OJ S 90/2025 of 12/05/2025 and earlier on the OJ S 60/2025 of 26/03/2025.

On 10 December 2025 at 09:30 AM CEST in a private session, held via Zoom at the link: <https://uso2web.zoom.us/j/85171233216> the following representatives of ANCI Toscana gathered to open the GoodGrants™ platform and finalise the supplementary competition for the Sofia lot as per the instructions contained in the Decree No. 278/25/I dated 4 December 2025 of the Director General of ANCI Toscana:

- Ms Elena Conti, on behalf of Simone Gheri, RUP (Single Responsible Person) of the whole Innovation Partnership procedure;
- Mr Besnik Mehmeti, component of the Evaluation Committee;
- Ms Giulia del Turco, acting as Secretary and authoring these minutes;

The aforementioned attendees were assisted by Mr Francesco Molinari, from the CLIMABOROUGH project team.

The meeting starting point was the *ex aequo* result between the two applications listed below, both having been ranked in the second and final useful position for the Sofia Lot during the last public meeting of the Evaluation Committee for this Innovation Partnership, held on 28 November 2025:

As prescribed by the aforementioned Decree, the two applicants were granted a new term of 5 calendar days following the reception of ANCI Toscana's communication regarding the



publication of the Decree, to resubmit their Financial Offer, with or without modifications. The GoodGrants™ platform was consequently reopened for them. The term expired on 9 December at 23:59 CET. The Decree also stipulated provisions in the event of no resubmission of a Financial Offer by either applicant, or in the case of a further ex aequo result.

Mr Mehmeti opened the GoodGrants™ platform and confirmed that both applicants had resubmitted their Financial Offers. These were opened and, based on the discount provided, the following scores were unequivocally attributed, in accordance with the Tender regulations:

By summing up the scores attributed to the resubmitted Financial Offer to those corresponding to the original Technical Offer the following result was obtained:

The new total score does not modify the ranking established during the Evaluation Committee meeting of 28 November 2025 but serves only to identify which of the two applications should be provisionally awarded. Consequently, this application is identified as app. No. 528 "Neutrality Story Maps (NSM): A Digital Tool for Citizen Engagement in Sustainable Waste Management".
